Pool Opening Soon!!!

The Recreation Center staff and Rocky Mountain Aqua Care are working together to obtain the necessary parts and supplies to get the pool up and running for the season. As always, our goal is to open the pool on the Saturday before Memorial Day:



There is much to do and supply-chain issues continue to cause delays, but we are still on track and remain optimistic that the pool will open on-time. Who can use the pool?

- 1. Owners of Property within the Ventana Metropolitan District.
- 2. If the home is leased, the Property Owner (Landlord), <u>may</u> authorize their tenants to use the facilities in lieu of the Owner. Since the Owner is ultimately liable for any damage caused by their tenant, the Owner may also choose not to permit their tenants to use the facilities in their name.
- 3. Residents of the City of Fountain (outside of Ventana) have the option of purchasing an Annual Membership, which allows the members of their household to use the facilities for a fee of \$600 per year. This option is also available to residents of Ventana whose Property Owner (Landlord) has not granted them access to use the facilities, who wish to obtain their own access.
- 4. If you qualify for access under items 1-3 above, you may invite up -to 4 guests at a time to accompany you to the facilities. Guests must be signed-in by the Owner, Tenant, or Fountain Annual Member whose guest they are and a fee of \$5.00 per guest will be billed following the visit.

A valid key fob is required to enter the Recreation Center and pool area. Additional key fobs can be ordered for a fee of \$40 each by submitting the online Key Fob Request Form at:

Spring Projects

LANDSCAPE: Weisburg Landscape is working their way through the public tracts to complete the Spring Clean-Up. Spring Clean-Up includes:

- Charging the irrigation to ensure all lines are running with proper coverage and sufficient run-times.
- Identifying any breaks or shortcomings in the irrigation system and providing a quote for repairs.
- Providing an initial mow, trim, and edging on turf as well as along all sidewalks, trails, and walkways.
- Fertilizing the turf in the Kentucky Bluegrass lawn areas.
- Fertilizing and applying weed control in the native grass areas.
- Applying pre-emergent throughout all rock beds.
- Aerating the Kentucky Bluegrass lawn areas.
- Removing dead material, trash and debris from rock and mulch beds and at the base of shrubs.
- Pruning of shrubs and deadheading of grasses.

The full scope of Spring Clean-Up will be completed by early June. Please contact Management if you have any questions or concerns throughout this process.

PARK: Rocky Mountain Playground Services will be making repairs to certain equipment at Ventana playground, as well as replenishing the Playground Mulch in late May.

TREES: The District is still awaiting approval for the landscape plan revisions submitted last summer, but in the meantime, we are working on obtaining proposals for replacement of the many previously removed (dead) trees. We hope to move forward with the first wave of replacements as soon as approval is received from the City.

POOL: The repairs needed to get the pool up and running this season are immense with plumbing repairs, heater repairs, pump replacements, chlorination feeder repairs, sand replenishment, filter repairs, light replacements, grate replacements, rust removal, caulking, sealing, patching, and timer replacement.

ARCHITECTURAL APPLICATIONS: As you approach spring and summer projects at your home, remember to submit your Architectural Application with time to approve before your estimated start-date.
