Snow Removal Responsibility:

- Residents are responsible for maintaining the sidewalk area between their property and the public street. The Ventana Metropolitan District is responsible for snow removal in front of mailboxes, the sidewalk area around the Recreation Center, and concrete sidewalks for the park.

Parking on Public Streets:

- Although the streets are public owned and maintained by City of Fountain, please be courteous when parking alongside neighboring properties. Be sure to not block your neighbors access to their property, sidewalks, or abandon your vehicles along their property line.

2022 Board Elections (visit the website Election Info page for details):

- If you are interested in being on the Ventana Metropolitan District Board, self-nominations can be submitted to the DEO between 1/1/2022 – 2/26/2022.
 - You must be a Colorado Registered voter AND either live within the district boundaries, own property within the district boundaries, or be the spouse of a property owner.

2021 – 4th Quarter Billing Highlights:

- 4th Quarter bills went out on 10/7/2021
- 168 Reminder Letters were sent on 11/2/2021
- 19 new liens have been filed and 7 liens remain in effect.

Billing:

- All Ventana Residents are billed on a quarterly basis that consists of \$135 per quarter. The breakdown of the cost of dues are \$45 per quarter for Trash service (this includes one bin for trash and one bin for recycle) and \$90 per quarter for Recreation Center Dues. If you have opted to add an additional Trash bin your trash service cost is \$54 per quarter.

Landscaping:

- You may notice the District do some winter watering. Due to an expected dry winter, you may see the irrigation run to avoid killing any landscaping.
 - Filing 6 tracts are still the Developers responsibility to maintain, and the responsibility will transfer next Spring.
