#### **Dogs and Fence/ Property Lines:**

- Please be cautious if you have a large breed dog(s) and the condition of your fence:
  - o If you have a large breed dog(s), that are able to bend or break the vinyl fence as others walk the neighborhood, please have proper precautions in place to help prevent this incident from occurring.
  - o If you have a fence line that jolts down to allow dogs less than the typical 5 feet to jump a fence, please take proper precaution to help prevent an incident from occurring.
- Please be courteous while walking your dog and make sure you clean up after your pet if they are in your neighbor's yard.

#### **Snow Removal Responsibility:**

• Residents are responsible for maintaining the sidewalk area between their property and the public street. The Ventana Metropolitan District is responsible for snow removal in front of mailboxes, the sidewalk area around Recreation Center, and concrete sidewalks for the park.

 Please be sure to prep your irrigation systems for the cooler weather, and make sure weeds are taken care of to avoid tumble weeds rolling through the neighborhood. As always you can reference the Design Guidelines and CCR's online to make sure you stay in compliance.

# 2021 – 3<sup>rd</sup> Quarter Billing Highlights:

- 3<sup>rd</sup> Quarter bills went out on 7/7/2021.
- 76 Reminder Letters were sent on 8/2/2021.
- 18 Collection Letters were sent on 9/2/2021.
- 11 New Liens filed.
- 6 Original Liens remain in effect.

#### **Billing:**

• All Ventana Residents are billed on a quarterly basis that consists of \$135 per quarter. The breakdown of the cost of dues are \$45 per quarter for Trash service (this includes one bin for trash and one bin for recycle) and \$90 per quarter for Recreation Center Dues. If you have opted to add an additional Trash bin your trash service cost is \$54 per quarter.

#### Landscaping:

• Filing 6 tracts are still the Developers responsibility to maintain, and the responsibility will transfer next Spring.
