Reminders from the Rec Center

You will start to see water and activity at the Pool starting the first week in May. We plan to open by May 20th, pending chemical balancing. Additional updates regarding pool opening will be placed on the district website as they become available.

Each household was provided 2-fobs when initially moving into the District. Additional or replacement fobs can be purchased for a fee of \$40 each.

Please be sure to not open facility doors or pool gates to let others in. There is always a reason why someone may not have access (past due account, does not live in the community, access has been suspended for violation of rules). If your fob has stopped working be sure to contact Management to help figure out why.

The District has an extensive wish list for repairs and upgrades at the Rec Center so every dollar counts. The Board and Management are working diligently to help provide the necessities with a tight operating budget.

Covenant Inspections

Regular inspections are conducted of the community to ensure covenant compliance. The covenants are intended to ensure the quality, value, desirability, and attractiveness of all properties within the Community. Below are just a few of the most common violations that we look for during inspections.

- Lawns and plant beds should be well maintained, weed free, trimmed, and clear
 of dead patches.
- Exterior surfaces: including garage doors and fencing should be damage free.
- Pets must be leashed and the leash must be controlled by a responsible person. Tethering and off-leash pets are subject to a \$20 fine for each incident.
- Pet waste should be picked-up immediately after each movement. Allowing waste to remain on the ground for any period of time, creates a health concern for neighbors.
- Trash and Recycle Bins should be stored in orderly fashion, against the home or behind a fence when it is not a scheduled pick-up day.

Each independent violation may result in a fine, so multiple violations may result in multiple fines. Please take a moment to address any concerns before our next inspection. Reference Article IV of the Covenants for clarification on these standards.

<u>Fire Lanes:</u> The Fountain Police Department recently contacted Management regarding ongoing issues with vehicles parked in the fire lanes throughout the community. We must stress to all residents and their guests that emergency access to the fire lanes is directly associated with the safety of all residents. Parking in the fire lane puts the health and safety of all residents at risk. If you witness a vehicle parked in a marked fire lane, please report it immediately to either City of Fountain Police or WSDM—District Managers.

<u>Street Signs:</u> At the April Board Meeting, Management was made aware of several damaged street signs within the community. The City of Fountain is responsible for the repair and maintenance of all street signs in the neighborhood. Spring Cleaning

Spring has sprung and with it comes Spring Cleaning!

If you plan to eliminate a bit of clutter in your home by hosting a sale, there are a few things to keep in mind:

- The City restricts garage/yard sales to 4 sales per year and each sale may only last 2-days.
- The City requires that private sale signs include the address where the sale is taking place. There can be citations if the a sign does not include the address and can be linked to your sale.
- Sale signs must be removed at the end of the last day of the sale. Signs remaining posted in public areas after a sale has ended can result in citations from the City.
