## **June Updates**

Following the delayed opening of the pool, a number of concerns have been brought forward by the Board and residents, which we would like to take this opportunity to address.

### Pool Maintenance:

- At the start of the season, the Board engaged a 3rd party to service the pool. This service agreement was terminated after less than a month due to inconsistencies and a lack of quality in the service.
- As of June 21st, the pool has reverted back to being serviced and maintained entirely in-house and the Board is brainstorming options for upkeep within the constricted budget.

#### Pool Behavior:

- Residents bringing alcohol, food, and glass into the pool area have created a health and safety risk for other guests, in addition to clogging the skimmers with trash. Alcohol, food, and glass are prohibited within the fenced pool area.
- Loud music, inappropriate conversations, and use of profanity have caused a headache for the young families hoping to enjoy some PG rated fun in the sun. Respect for the innocence of children and common courtesy for families must be employed while at the facility.
- Young children and intoxicated adults continue to be witnessed using the hot tub. Any person under 115 lbs or inebriated in any manner is not permitted in the hot tub for any period of time.
- All swimmers should shower before entering the pool to get rid
  of particles and dirt on their person, which would otherwise end
  up in the pool. Not only is this more hygienic, it reduces the
  possibility of sharing communicable bacteria and parasites.

## Restroom Etiquette:

- Feces, sanitary napkins, tampons, and diapers are just a few of the foul items that the Rec Center staff has cleaned up over the past few weeks, which is simply unacceptable.
  - Younger children who still have accidents must wear swim diapers.
  - Make sure all waste makes it into the trash cans, with no exceptions.

Covenant Enforcement will be a central point of focus for the month of July, with inspectors coming through each week to ensure every property is being up-kept.

Here are a few of the primary complaints your neighbors have submitted and key items we will be looking for:

- <u>Lawn Care</u>: Lawns should be mowed, weeded, and free of bare spots.
- Rock & Mulch Beds: Beds should be free of weeds and contain sufficient rock or mulch to cover all dirt.
- Porches & Driveways: Personal items, tools, and toys cannot be stored in the front of the home.
- <u>Backyards</u>: Backyards should be mowed, trimmed, weeded, and free of pet waste at all times.
- <u>Homes</u>: Homes must be free of chipped paint, broken windows, damaged gutters, and dented garage doors.
